4a (Code:) (Expenses \$ 1,974,295 including grants of \$) (Revenue \$ 2,251,649) Visitor Services (includes Guest Services department): designed to provide information services, process membership benefits, coordinate tour groups, perform introductory lectures, assist with special events and collect entrance fees. Staff monitors multiple park entry points as well as information desks located throughout the park. Public safety personnel have been hired to monitor the facilities and grounds, assist with crowd management for mission related activities, rental events for individuals, corporations and other nonprofit organizations. Additionally volunteer services are managed and provide over 150 volunteers and docents with more than 7,000 hours to assist patrons and programming initiatives.

4b (Code:) (Expenses \$ 1,143,958 including grants of \$) (Revenue \$) In 2015, over 230,000 people visited GFS. As with park sculpture, GFS embraces a wide range of contemporary sculpture and related art in its exhibitions. In 2015, GFS presented eleven major exhibitions, five education gallery shows. Featured exhibitions included works from Jae Ko, Karl Stirner, Jonas Stirner, Robert Lobe, Nikki Rosato, Lauren Clay and the 10th Annual International Sculpture Center Outstanding Student Artists show as well as a group called Disruption. Featured education shows included Reflections in the Classroom, Members' Musing, GFS History: The Land in Pictures, Focus on Sculpture and Into the Beautiful North: A Big Read Mural Project. Periodically GFS adds new outside sculptures; there are currently over 270 sculptures on site. All of GFS' works in the park and current exhibitions can be viewed on its website www.groundsforsculpture.org.

4c (Code:) (Expenses \$ 850,759 including grants of \$) (Revenue \$ 139,938) ARTS EDUCATION: Grounds For Sculpture runs free, educational programs specifically developed to address the needs of vulnerable populations in our community, including seniors, at-risk teens, homeless children, veterans and adults with cognitive and physical impairments. As a community arts organization, we constantly strive to improve and expand our programs and services as part of our commitment to accessibility for all. In 2015, GFS offered 90 workshops, lectures, and demonstrations for children, adults and families. Additionally, GFS offered more than 642 tours. In 2015, 14,000 children visited and there were 371 scheduled school trips. The Education department also conducted 37 professional development workshops and 8 special needs workshops. GFS doubled its mobility vehicles, created an online accessibility brochure, and conducted 830 group tours for 2,713 mobility impaired individuals. GFS launched a horticultural initiative with tours and training.
